# Campaign: Cards do Futebol

### Terms & Conditions (the "Terms")

Please note: Virtual assets and NFTs are not regulated in Brazil. Fan Tokens shall not be considered a type of investment as their essential function is to allow access to specific goods, services or functionalities by means of a blockchain-based infrastructure.

## Campaign:

- 1. This Campaign is called "Cards do Futebol" (the "Campaign").
- 2. The Campaign is jointly carried out by Gotas Ltd, a company incorporated under the laws of the United Kingdom, under the number 1507459 with registered address at Registered office at 128 City Road London EC1V 2NX United Kingdom and Socios Technologies AG, a company incorporated under the laws of Switzerland, (hereinafter collectively referred to as the "Co-Promoters").
- **3.** Gotas Ltd provides the technology platform for the campaign, which will consist of the following: Cards do Futebol is a collection of non-fungible tokens (NFTs) minted on the Gotas Social platform. For the avoidance of doubt, Socios Technologies AG and its affiliates are not involved in the minting process.

#### **Description of the Campaign:**

- **4.** The Campaign is open to participants ("**Participant(s**)"/"You"/"Your"/"Yourself") who stake Fan Tokens™ from the following teams: Flamengo, Fluminense, Vasco da Gama, Palmeiras, São Paulo FC and S.C.Internacional to mint NFTs which will be acquired later on by You. You will be able to mint new NFTs until the campaign is over or the supply of that rarity is sold out.
- **5.** The Campaign will run from 21 July 2025 (the "**Opening Date**") to the 22 December 2025 (the "**Closing Date**"). Anyone who attempts to participate following the Closing Date will not be eligible to participate and will not be considered. Notwithstanding the foregoing, the Promoter reserves the right, in its absolute discretion, to consider submissions made after the Closing Date.
- **6.** The Campaign will run on gotas.social platform.
- 7. In order to participate in the Campaign, you MUST;
  - A. Be aged eighteen (18) or over;
  - B. Own Fan Tokens™ of the following Brazilian Football teams: Flamengo, Fluminense, Vasco da Gama, Palmeiras, São Paulo FC, S.C.Internacional, and EC Bahia
  - C. Stake your Fan Tokens™ and mint up to three (3) cards per club every day, until the end of the Brazilian Football season.
  - D. Have a Socios.com wallet or any other compatible. For the avoidance of doubt, Participants during the staking period, accrue **Reward Points ("RP")** in accordance

with the **Stake & Earn functionality** governed by **Section 10.8.6 of the Socios.com General Terms of Use**.

- E. Have your residence in Brazil.
- F. Follow the following steps:

#### 1. Connect Your Wallet

Head to your team's page on cardsdofutebol.com and log in with your wallet: Socios.com, Gmail, MetaMask, Apple or another option.

## 2. Choose Rarity

Select Legendary, Epic, or Common. Legendary unlocks all three (3) tiers:

- Legendary: 1,000 Fan Tokens™ required
- Epic: 200 Fan Tokens™ required
- Common: 100 Fan Tokens™ required

For the avoidance of doubt eligibility for each category will depend on the amount of Fan Tokens™ staked at the time of the minting.

#### 3. Stake Fan Tokens™

Lock the required Fan Tokens™ at Socios.com wallet or directly at cardsdofutebol.com.

## 4. Stake Once, Mint Daily

Hit "Mint" and claim your unique one-of-one Al-selected collectible! Come back daily for more drops. You do not need to stake again, so enjoy fresh drops daily!

For the sake of clarity, Participants may initiate the un-staking process at any time. Once initiated, a cooldown period of seven (7) days will immediately begin.

During the Cooldown Period, the locked Fan Tokens will remain in a transitional state within the smart contract and cannot be traded, transferred, or otherwise used. Additionally, users will not be eligible to proceed with any minting actions during this period.

- **8.** Participation in the Campaign is free and no purchase is necessary, unless otherwise specified herein.
- **9.** The Co-Promoters accept no responsibility whatsoever for entries not successfully completed due to a technical fault of any kind.
- **10.** The NFTs acquired are unique, non-exchangeable, non-substitutable and no cash alternative is offered by the Co-Promoters.

**11.** Any aspect or benefits in relation to the Campaign shall be strictly limited to that described herein these Terms are hereby being explicitly excluded.

## **General provisions**

- **12.** The decision of the Co-Promoters regarding any aspect of the Campaign is final and binding, and no correspondence will be entered into about it.
- **13.** Participants are deemed to have accepted and agreed to be bound by these Terms upon entry into the Campaign. The Co-Promoters reserves, at its sole and absolute discretion, the right to, at any time, refuse entry, disqualify, or refuse participation to anyone in breach of these Terms and/or any applicable law.
- **14.** If a Participant uses fraudulent methods or otherwise attempts to circumvent these Terms, such Participant shall be discarded at the sole discretion of the Co-Promoters
- **15.** The Co-Promoters reserves the right to hold void, cancel, suspend, or amend the Campaign at any time when it becomes necessary to do so. The Promoter reserves the right, at its sole and absolute discretion, to replace the NFTs with an alternative NFT(s) if circumstances beyond the Co-Promoter's control make it necessary to do so. Due to the outbreak of pandemic (including but not limited to Corona Virus (COVID-19) and monkeypox), should the delivery of the Fan Tokens™ or the NFTs minted be reasonably difficult to execute or impossible, then the NFT may not be delivered to the Participants in which eventuality, the Co-Promoters shall not be responsible for any expenses or damages whatsoever sustained by the Participants in connection with the mechanisms necessary to participate in the Campaign.
- **16.** Insofar as is permitted by law, the Co-Promoters, its agents or distributors will not in any circumstances be responsible or liable to compensate the Participants or accept any liability for any loss, damage, personal injury or death occurring as a result of taking up the NFTs except where it is caused by the gross negligence of the Co-Promoters, its agents or distributors or that of their employees. Your statutory rights are not affected.
- 17. The Co-Promoters reserve the right, at its sole discretion, to change, modify, add to, or remove portions of these Terms & Conditions at any time without prior notice. Changes will be effective when posted on the Campaign platform or website, and it is the Participant's responsibility to review these Terms & Conditions periodically for updates. Your continued participation in the Campaign following the posting of changes will mean that you accept and agree to such changes. In the event of material changes that may adversely affect your rights under these Terms & Conditions, the Co-Promoters will make reasonable efforts to notify Participants through the communication channels as deemed appropriate by the Co-Promoters.
- **18.** By entering in the Campaign, participants accept and agree to participate in publicity material related to this Campaign only, which may include the publication of the Winner's name and images in any media (including social media) of Socios.com and Fan Tokens and any of the Co-Promoter's affiliates. The Winner/Participants may be required to participate in promotional filming of the Campaign. Such filmed content may be used by the

Co-Promoters and its affiliates. All rights, including image and property rights, arising from the creation of any film material or content shall remain the sole property of the Co-Promoters and its affiliates.

Nevertheless, we want to inform you that you have the right to be informed in a clear, transparent, and understandable way how we use your personal data in connection with the Campaign; request access to your personal information; request rectification of the personal data that we hold about you; request the erasure of your personal data; object to the processing of your personal data where we are relying on legitimate interest; request the restriction of processing of your personal data; request the transfer of your personal data to another party where you provided it to us, and we are using it based on your consent; withdraw consent at any time by sending an email to dataprotection@socios.com; and lodge a complaint before the suitable Supervisory Authority in Switzerland or in the United Kingdom if you think that we are using your information in a way which breaches Data Protection Laws.
